1. Stages will be setup with a complete sound system, including microphones, and CD player. Please bring your own instruments and amplifiers. There will be someone on hand at each stage to ensure a trouble-free performance.
2. Please be aware that all applicants will be reviewed. This selection process is necessary due to the amount of applications received. As a result of the review process, the Olde Towne Fall Festival does not guarantee acceptance to those who have participated in past festivals.
3. Bands or individual performers must supply an example (CD) of their music or performance with the application.
4. All participants must sign the release statement in order for the application to be accepted.
5. The Olde Town Fall Festival reserves the right to reject any organization whose presentation, goals, or objectives may be offensive and not in the best interest of the community.
6. The APPLICATION DEADLINE IS July 17, 2008.
7. An entertainer failing to meet all of the requirements and regulations may be asked to leave the festival area.
